**Background**: You have been temporarily diverted from your original job with E.R.I.N. and requested to instead perform this mission for Chauncy Enterprises and Mrs. Olson's family. You have already received the corporate briefing from E.R.I.N. however this briefing will focus on the additional things you need to know in order to be able to perform this mission for Chauncy.

To sum up some of what you may have already received, Mrs. Olson is a brilliant electrical engineer for E.R.I.N. and is working on high level green energy projects that are tied to significant federal grant funding. Her husband, Douglas, did die in an automobile accident in 1985. She has three children, Kevin, Nathan, and Laura. Although Chauncy can not totally confirm with 100% assurance that Mrs. Olson has stolen company *proprietary* information, there is ample evidence that information has been taken. Mrs. Olson has requested to go on an extended leave to San Alfonso del Mar in the city of Algarrobo, Chile. Her three children, Kevin, Nathan, and Laura are meeting you here today to impress upon you the importance of what they want you to do and why they

hired Chauncy to intercept your mission from E.R.I.N. and to instead offer all of you to work this job for them.

Nancy Olson has maintained a very close relationship with all of her children. They are very worried about how E.R.I.N. is handling this case. The children, in coming to Chauncy Enterprises, have requested that the agents continue to perform the mission under their E.R.I.N. cover but instead of returning Mrs. Olson back to E.R.I.N., return her to the family. The children said that they are in great fear for their Mother's life. They report that their Mother has discussed a great deal about her dissatisfaction with E.R.I.N. and these green energy



projects. Their Mother has informed them that E.R.I.N. is involved in some shady dealings with the current US Administration. They don't know all of the details but they do know that their Mother previously tried to take some corporate information to several media outlets, various government officials, and even various justice officials as a whistle-blower but that no one took her up on the offer and she became very disallusioned. After a brief period where they felt that their Mother had given up on this, she suddenly became very interested again and indicated that that is why she

was going to go to San Alfonso del Mar. Mrs. Olson relayed to her family that she had met someone working for E.R.I.N. that encouraged her to seek out another news options that just might publish this information and expose the corruption of E.R.I.N. and the US government. The children don't know who this person inside E.R.I.N. is. However, they do know that at the resort she was to meet a reporter from the International Consortium of Investigative Journalists (ICIJ). A photo of this journalist was sent by their Mother to them and is included in this briefing. The children do not know who this journalist is. The initial meeting took place on December 13, 2010, where their Mother turned over some information, sort of like a preview of what was to come. After the reporter had some time to attempt confirmation of the information that Dr. Olson had given the reporter, they would

meet back up on December 17, 2010 at 2pm local time at the pyramid in the center of San Alfonso del Mar resort and if the reporter was satisifed with the information, Dr. Olson would provide the

remaining bulk of the information to the reporter. The children don't know what method Dr. Olson used to transport this information. It could be physical files/documents, computer disks/drives, USB thumb drives, etc. The children have reason to believe that if Dr. Olson is returned to E.R.I.N. that E.R.I.N. will place her in a hospital or jail in order to silence her. Once there and out of reach of the family, they fear what will ultimately happen to her. Many powerful people want Mrs. Olson to be kept quiet.

Insertion & Extraction: Continue to do whatever E.R.I.N. has already laid out and provided. The only change being that when returning to the US, the agents need to divert the plane so it lands at Sugarland Regional Airport on the outskirts of Houston instead of returning to George Bush Intercontinental Airport in Houston. Once Dr. Olson has been transferred off of the plane to Chauncey staff and Dr. Olson's family, the agents can continue on to the George Bush Intercontinental Airport if they wish. It is up to the agents what they feel they need to do regarding the E.R.I.N. pilots of the Gulfstream.

Your missions are listed below.

#### Mission:

- 1. Retrieve Dr. Olson and return to her family.
- 2. Obtain any unusual and/or exotic weaponry.
