MISSION BRIEFING

Travel Arrangements: Agents are contacted by E.R.I.N. and told to travel to Houston, Texas with utmost haste. Agents MUST be at the George Bush Intercontinental Airport at Houston by December 16, 2010 by 8pm. Agents will then meet a contact who will transport them by agency vehicle to a temporary safehouse on the outskirts of Houston. Agents are advised to have with them at this point all items they are planning on taking with them (e.g. weapons, explosives, special items, etc.) Once the agents are in Houston, the agency will provide all transportation from that point till the end of the mission.

The employee's name is Dr. Nancy Olson. Dr. Olson is a brilliant electrical engineer at E.R.I.N. who worked on various alternative green energy projects that are closely tied into federal grants out of the Houston office. Agency officials have informed this division that Dr. Olson had recently arranged to take an extended leave for a long overdue vacation and notified the company that she would be traveling to this resort. Mrs. Olson is a widow as her husband, Douglas, died tragically in an automobile accident back in 1985. She has three children (Kevin, Nathan, and Laura) who are all adult children and living in different parts of the country. Dr. Olson had planned to take this vacation all alone in order to unwind and provide respite from strenuous activities at the agency. Since this was significantly out of character for Dr. Olson, agency officials quietly conducted an internal investigation into Dr. Olson's activities. 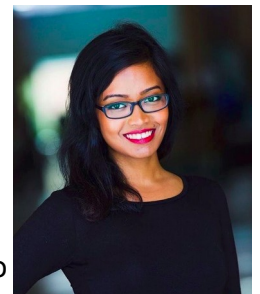

Insertion & Extraction: E.R.I.N. will be providing all transportation for the agents. A Gulfstream jet is currently in the process of being fueled and will be ready to leave as soon as the agents can get to the George Bush Intercontinental Airport at Houston. The agency is providing transportation via an agency limosine that has been cleared with airport officials to allow entrance through the private entrance of the airport for VIP's, thus bypassing security. Your cover will be as a reporter and crew for a new start-up vacation magazine/website,

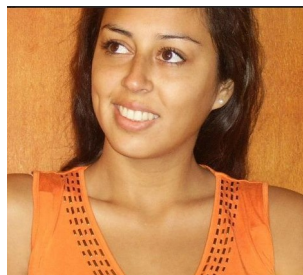
Mission:

4. Obtain any unusual and/or exotic weaponry.

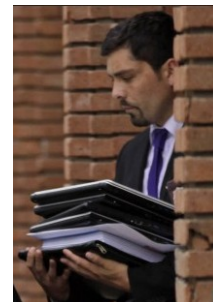
Payment:
